Since it is a common practice for one spouse to handle all financial issues in a household, the other spouse usually has little or no information regarding financial matters. And it is also common for the spouse with the information to delay, avoid, or even refuse to divulge such information to the other spouse. In the discovery process, a formal request can be made for any or all financial information.
