Immediately after a truck accident, the first thing to do is to ensure that there is no longer any danger. For instance, if the accident occurred at an intersection, the first thing to do is to get out of there because of the risk of getting hit by oncoming vehicles. After ensuring one's safety, it is time to call the emergency services. It is important to seek medical attention even if it seems that there are no apparent injuries. Because of the adrenaline released by the body, it may be possible to have sustained an injury but feel no pain right after the accident.

Thus, it is important to have a medical check-up right after the accident. And when the police arrive, a truck accident victim must file a police report for the accident. Having a copy of the police report is essential because it will be needed later on when filing a claim. Meanwhile, if there is a need to call one's insurance firm, it is important to inform them only about the essentials. It is also a good idea to get the contact information of the other driver in the accident and jot them down, including the name of the trucking company.

Photos of the actual accident must also be taken, showing the damage to one's vehicle, the truck, and any injuries. If there are witnesses of the accident, it is also important to get their contact information to be able to get a testimonial from them later on.

Finding a personal injury lawyer who specializes in truck accidents is vital. It is important to note that there are usually no upfront costs when hiring a truck accident lawyer because they usually work on a contingency fee basis, which means the victim only gets to pay an attorney's fee only after a settlement has been reached. This kind of arrangement is the best because it means the lawyer will be seeking to maximize the compensation.
