Unlike in Windows 10, apps can?t float anywhere on a screen. Instead, apps in Windows 10X open on a single screen by default and the user can drag them across the display with a touch or a mouse to have the apps span across the two screens. Attempts have also been made to make the controls and notifications look better in the Windows 10X. However, iPadOS may still be better in not letting such controls and notifications too distracting and by allowing gestures to access them.

With regards to apps, iPadOS remains on the advantage because of the broad range of apps that can be

obtained from Apple?s App Store. With Windows 10X, it supports Universal Windows Apps, Win32 apps, Microsoft Store Apps, and Progressive Web Apps. However, the variety of the apps available from the Microsoft Store is still inferior to that of Apple?s App Store. And another problem with Windows 10X on dual-screen devices is apps having to work on the dual screen, which sometimes results into some problems.
