Information shared by Carabin Shaw P.C. reports that, according to a National Highway Traffic Safety Administration survey, 20% of drivers age 18-20 said texting does not affect their driving, and nearly 30% of drivers ages 21-34 said texting has no impact. However, each day in the United States, approximately nine people are killed and more than 1,000 are injured in crashes that are reported to involve a distracted driver.

Data shows that, at 55 mph, sending or reading a text takes a driver's eyes off the road for about five seconds, in which time the driver will have covered a distance long enough to cover a football field and expose themselves and others to unnecessary danger. In fact, studies conducted by the AAA Foundation for Traffic Safety have shown that taking one's eyes off the road for more than two seconds doubles the risk of a crash.
