A personal injury, according to the law, is any physical, mental, or emotional harm that has been experienced by a person through the direct actions, inaction, or negligence of a third party. According to US law, a person who has suffered personal injury can seek compensation from the third party who can be proven to be responsible in some way for causing the injury.

According to the article, there are two possible ways to seek compensation. First is the settlement agreement. This is an agreement that is reached out of court where both parties agree to a certain monetary or other type of compensation. However, when a settlement agreement has been reached, the injured party will no longer be able to file a lawsuit in the future to receive future compensation for the injury in the event that unforeseen or long-term problems arise due to the injury. Thus, it is highly recommended that person injury victims only enter into a settlement agreement on the advice of a personal injury lawyer who provides representation during the negotiation period for the settlement. The other way to seek compensation for a personal injury is through a lawsuit. The individual who suffered the personal injury and brings the lawsuit is known as the plaintiff, while the third party who is being sued is known as the respondent. The plaintiff, with the help of a personal injury lawyer, will have to present evidence to the court for the physical or psychological injury that was sustained, including proof showing how the respondent is responsible for the injury. The plaintiff, with the help of a personal injury lawyer, will also have to enter the amount of compensation that is being asked for.

Such lawsuits can develop into long, drawn out affairs that can be very costly. Respondents often have insurance for personal injury lawsuits that provide the legal representation. This legal representation will employ legal tactics designed to win the case or reach a situation where the plaintiff can no longer handle the expenses to pursue the lawsuit. It is therefore imperative for the plaintiff to get legal advice and representation from an experienced personal injury lawyer. The attorneys at Kenneth S. Nugent, P.C. - Valdosta can evaluate the case, the amount of compensation to be requested, and whether there is enough evidence for the court to find the respondent liable.

There are two kinds of compensation that the plaintiff can seek for in a personal injury case. The first type is known as compensatory damages. These include any expenses or financial losses suffered by the plaintiff as a direct result of the personal injury. These will usually include medical expenses, future medical care, loss of income resulting from an inability to work or earn an income for a certain period of time, additional expenses that may arise, cancelled or altered plans, and the pain and suffering or mental anguish resulting from the personal injury.

The other type of compensation is known as punitive damages. Such damages are awarded to the plaintiff at the discretion of the court and involve bad behavior or wrongdoing by the respondent that caused bodily or psychological harm to the plaintiff. Punitive damages are awarded over and above the compensatory damages and are basically a penalty or financial punishment imposed on the respondent for the wrongdoing or bad behavior.
