This requires the presence of an expert witness who will state that the patient had received substandard care. This expert will take into account the accepted standards of medical practice within that local community and then evaluate whether the provider had failed to comply with those standards. Next, the patient must be able to provide evidence that he or she was harmed by the negligence of the health care provider.

Victims of dog bites may also seek for compensation. In most cases, it must be shown that the dog owner has knowledge that his or her dog has dangerous and vicious tendencies. If the owner knew this and had failed to restrain the dog, he or she may be held responsible for any injuries caused by the dog bite.
