The statistics also dictate that the people more affected by these incidents are vehicle drivers and passengers, showing that 73% of all tractor-trailer accident injuries and fatalities are suffered by people in the vehicle hit by the truck, while truck drivers often make it out without injury."

It is due to these (and several other) reasons that those who suffered an injury in a truck accident are then often in a position to seek compensation for the truck driver's negligence and the harm it has caused. This compensation depends on the extent of the injuries and the long-term impact (or lack thereof) that it will have on the victim's life. Some of the most common injuries are listed in the Atlanta truck accident lawyer's article, starting with back and neck injuries.

Angell states, "This is the most common type of injury following a truck accident. These types of injuries can take a long time to show any symptoms, which is why it is so important to visit a doctor and get diagnosed soon after a truck accident. It is all the same whether you are experiencing minor neck or back pain, or more severe injuries such as dislocated discs in the spine. You want to keep a detailed record of the injuries sustained in the accident and how they may affect your daily life or work."

Head injuries should also be a concern for victims of truck accidents, as these, unfortunately, are also fairly common. Sustaining head trauma during a truck accident can result in brain trauma, which may be life-altering. Brain injuries can still occur even if the victim did not experience direct trauma to the head, and they may not be immediately apparent as well. Symptoms may take weeks to develop, and they may include confusion, nausea, vision problems and various cognitive difficulties.

Similarly, internal injuries can be difficult to spot in the immediate aftermath of an accident. It is not uncommon for blunt trauma from truck crashes to cause internal bleeding to organs like the bladder, liver, kidney, pancreas and spleen. These injuries are often challenging to treat as well as life-threatening in nature.

All of these injuries, among several others, can be used in court to prove stress and loss of quality of life for the victim.
