Although it is illegal to drive once your physical and mental capabilities are impaired by alcohol or drugs, it's not illegal to drink and drive. These are important distinctions. Clients are often aware that they are not required to consent to a sobriety test but not aware that failure to do so may result in a license suspension. Failing a breathalyzer test does not automatically result in a conviction. These tests are often used to establish probable cause to arrest the individual but will not be used in court.

In many cases, a first-time offender will be able to take advantage of impaired driver programs and conditional driving privileges. Repeat offenders are looked at more harshly by the courts. This is when having an experienced Queens DWI attorney on board can make a big difference in the defense and dispensation of charges. In either case, having the representation of an experienced lawyer can help clients avoid excessive

finer and possible jail time after DWI charges.

One of the first things I tell my clients who have been charged with a DWI is to start to make a habit of using Uber, Lyft, or other taxi services from now on if they plan to drink. These services are wonderful and convenient and allow all of us to have fun without getting behind the wheel afterward. A DWI charge can be financially expensive as well as emotionally devastating and put everyone's life in jeopardy. It can not only leave you with a license suspension or revocation but can even end in a jail sentence. A criminal charge can impact your ability to get a job or housing.
