This will allow them to assess the situation correctly and determine what needs to be done.

For instance, if anybody is injured, it would be advisable to call 911 to ensure that an ambulance will arrive at the scene of the accident. It may also be a good idea to call the Atlanta police department to ensure that a police officer will get to the scene to allow the filing of an accident report. This will make sure that the victim of the accident will be able to get an official police report that will be submitted to the insurance firm. Police reports are critical pieces of evidence when the victim has to prove his or her case when making a claim. And if the car is still functioning, it is also advisable to remove it from the main road.

It is also a good idea to exchange information on names and insurance data with the other party. Such information would be vital when an accident investigation is made and when filing an injury claim. However, it is also advisable to limit interaction with the other driver in order to avoid accidental admission of guilt. A free app like the WreckCheck from The National Association of Insurance Commissioners may be used to record important information such as the name, address and contact info of the other driver; insurance data; license plate number for each party; contact info of witnesses; phone number of the other driver; police report number; photos of any damage; personal notes on what occurred during the accident; and name and telephone number of the police officer.

Other things to do after an accident include: determining what insurance policy is applicable; contacting a personal injury lawyer; and consulting a chiropractor, such as one of the Arrowhead Clinic car accident chiropractors in Atlanta. It is important to remember that accident victims will need to seek medical attention

first before consulting with a lawyer. Early care and treatment are essential for a fast recovery, especially after serious injuries.

Move To A Safe Area and Check For Injuries After your car accident, you should immediately check for injuries. If you or anyone else involved in the accident is injured, call 911 to get an ambulance on the scene. You should also call the Atlanta police department to get a police officer at the scene of the accident so they can file an accident report. This ensures that you get an official police report that you can give to your insurance company. Police reports are often crucial pieces of evidence when proving your case. If your vehicle is still operational, get it off the main road.

Document the Accident and Protect Evidence Takes pictures of the accident scene, the vehicles involved, everyone involved, and anything else that might help explain the how and why of the accident. Pictures taken as soon as possible are most valuable. If you don't have a camera for some reason, see if a passenger or bystander can take photos for you. Be sure to take pictures of the damage done to all vehicles. Snap a few pictures of the other party's license plate and evidence like street signs, lights, skid marks, etc. Once you are in touch with an attorney after your accident, be sure to tell them about any other evidence you think might be necessary. Things like faulty street lights or signage, malfunctioning equipment like your seat belts, turn signals, and weather conditions, can all be essential information.

Exchange Information After an accident in Atlanta, Georgia all parties should exchange names and insurance information with each other. This way an accident investigation and injury claim can be defined properly. While you might want to talk in-depth about the accident, it's best to limit your interaction with the other driver so you don't accidentally admit guilt. You'll want to get as much information as you can, including:

- * Name, address, and contact information of the other driver..
- * Insurance Information
- * Each Parties License Plate Number
- * The other driver's phone numbers.
- * Witness contact information.
- * Photos of any damage.
- * Police report number.
- * Police officer's name and telephone number.
- * Personal notes on what happened during the incident.

If you have a smartphone, The National Association of Insurance Commissioners offers WreckCheck, a free app that records information like the time of the accident, and lets you create written and audio details. Once you're done it emails everything to you or your agent. Also, many insurance companies offer a similar app, so your insurance company may offer a free smartphone app to help you document the crash's details. If you don't have a smartphone app, but you have a pen and paper handy, you can draw a diagram of the scene and make notes about how the accident occurred.

Determine What Insurance Applies One of the biggest headaches after being involved in a car accident is dealing with insurance companies, knowing your insurance policy in full, and speaking with an insurance adjuster. How the insurance claims process shakes out for you after an accident depends on who was at fault and the types of insurance you and the other driver have. If the other driver was at fault, their property damage liability coverage will pay for repairs up to their policy's limit. Medical bills would be covered

up to the limits of the negligent driver's bodily injury liability coverage. If the other driver is uninsured or they don't have enough coverage to pay your bills, your uninsured or underinsured motorist coverages would payout. The negligent driver's expenses will be handled similarly. Collision coverage will pay for repairs up to the vehicle's actual cash value, minus a deductible. Their injuries would be paid by medical payments coverage, or MedPay, working in tandem with health insurance coverage. Emergency roadside service comes in handy if you need a tow to the repair shop. This service is available with a AAA membership. Still, it's often cheaper to get emergency roadside service from your auto insurer. The only downside is that using it will count as a claim, and claims can cause your rates to go up. Rental car coverage pays for a rental while your car is in the shop. Be aware that you'll probably need collision and comprehensive coverage to add rental car reimbursement and emergency roadside service.
