The average semi-truck weighs around 33,000 lbs. Any accident involving such a large vehicle ends with the truck coming out relatively unharmed while the smaller vehicle suffers extreme damage ? and the driver is often seriously injured if not killed outright. Semi-trucks present a very serious threat to other vehicles on the road if the proper precautions are not taken. If one finds themselves the victim in an accident involving a semi-truck, there are several actions they must take to ensure that the process of receiving care and compensation goes smoothly.

The first step to take in the event of an accident is to stay at the scene of the accident. It is always best to remain at the scene of the accident until authorities arrive, and it is even illegal in some states to leave before being cleared by officials. The next step is to check for injuries. Often, adrenaline makes it so accident victims do not feel their injuries until long after the accident, and it is important to check to see if there are any visible injuries that require immediate attention.

Another very important aspect to keep in mind is that everything must be documented. As the blog post says, ?As soon as it's safe to do so, and everyone has been checked for injuries, you need to document as much as possible. Take photos and videos of the accident scene, including the damage to all of the vehicles, any skid marks at the scene, and make an audio recording of what happened during the accident. Gathering this evidence is crucial because after the accident, your memory will fade as the days go on, and the trucking company will do all they can to prove that they were not responsible for it. Having evidence gives you a better chance to prove liability for your semi-truck accident. Also, don't forget to check your belongings inside your vehicle. Sometimes the contents of your car, like laptops or smartphones, can be damaged as well. Take pictures of everything in your car that was damaged because those values can be added to your final settlement.?

Several factors can lead to an accident but the most common among them may be negligence.
