previous record set back in 2016 by over a thousand voters. The blog post states that this created some long waits but those that had to even stand in line for over an hour took this all-in stride and were happy to have the chance to vote early. It also mentioned that some voters thought the long lines were a direct result of strict social distancing requirements that were put in place, but once they saw the record numbers of those who voted that day quickly understood that was not the case. That record number of voters on the 13th comes out to an average of just under 1000 voters visiting each of the Dallas area?s 61 early voting sites that day. The new post also pointed out that some of the longest waits of over 2-hours to vote took place at the Duncanville Library site and the only voting delays that were reported due to malfunctioning equipment took place at the Samuell Grand Recreation Center in East Dallas.
