One might think that minor pain and discomfort are normal after an auto accident. However, there are many reasons for one to seek medical help. These include soft tissue injuries that occur in the muscles and joints, leading to limited flexibility. The doctor may refer a patient to a massage therapist, physical therapist, or chiropractor for noninvasive treatments.
