There are three liability rules for determining responsibility for car accidents. Under no-fault laws, anyone with a vehicle in New York requires having no-fault insurance coverage. According to no-fault laws, each driver will initially look to his or her insurance for compensation for their damages. Under the rules governing negligence, when a driver has breached a duty of care and acted irresponsibly towards another driver on the road, resulting in an accident and injuries, this driver will be deemed negligent and liable for the collision. Under comparative fault laws, which are applicable in New York state, drivers will still be able to collect compensation from the other party as long as they are partially at fault for the accident. The amount of responsibility attributed to the drivers determines the percentage of the compensation for which they are liable.

K L Sanchez Car Accident Lawyers - Queens also handles cases related to construction injuries, workers' compensation, immigration, criminal defenses, and divorce. They claim to have recovered millions of dollars in compensation for clients who have suffered injuries as a result of the negligence of other parties.
