



## Former Royal Chef Now Catering In Dallas

Local bloggers in Dallas are buzzing that a former royal chef who cooked for the Queen and Princess Diana is now based in the area.

According to one local post, Chef Darren McGrady had cooked for the royal family of the United Kingdom for 15 years, but more recently he has lived and worked in Dallas for years now. The article says that Delish.com published a short article attached to a video they did with him published on April 7th where he recreated the Queen's favorite birthday cake.

According to the article in Delish.com, "Darren McGrady was the personal chef to Queen Elizabeth II, Prince Philip, Princess Diana, Prince Charles, and Princes William and Harry—a family with notoriously specific food needs—for 15 years. In 1998, he moved to the U.S.A. where he wrote best-selling cookbooks and founded Eating Royally, a fine-dining catering service based in Dallas, TX."

In that Dallas Morning article, they say "The Dallas-based chef, who once doted on Di, is now delivering his food to Southlake, beginning Tuesday, July 14.
