Only two states make it illegal to own stun devices (Hawaii and Rhode Island), and many states that once restricted the ownership of stun guns have updated and changed their laws over the years.

U-Guard has a list of rules surrounding the use of stun guns by civilians. It is important to understand the difference between a stun gun and a taser, the laws surrounding both and how to handle one. State laws are generally quite similar regarding both stun guns and tasers. Stun guns are usually direct contact, non-lethal electric stun weapons that must touch the body to work. Tasers fire darts from a distance which administer an electric shock to incapacitate the attacker. In most states, one can purchase a stun gun without a permit.
