Tasers are actually legal in most of the states, with only the states of Hawaii and Rhode Island prohibiting the purchase, possession, and use of tasers for civilian self-defense, as of early 2020. It is important to note, however, that it is not legal to use an electric shock device for committing a crime or in such a way that could result in breaking the law.

The good news is that the laws governing the two are very similar, and the details are provided in our educational page for taser that will provide the answer to the most common questions about tasers and whether it is legal to carry a tazer or simply own one in a particular city, county, or state.?

Since many people are confused when it comes to differentiating the taser or taser gun with a stun gun, the above-mentioned educational page explains how they differ. A taser is an electric shock device that shoots projectile darts and are generally more costly and have more advanced features compared to stun guns. Most stun devices are direct contact non-lethal electric shock weapons. Thus, stun guns must touch the body for a few seconds to be able to function properly. Meanwhile, tasers may be used as a stun gun in the event that the stun dart cartridge has been removed or all the darts have already been used. Many of the taser models will shoot two stun darts on a thin cable from a one-time use replaceable taser cartridge. Click to learn more about taser laws.

The primary advantage of a taser over a stun gun is that it allows the user to keep away from the assailant for distance of about 8 to 20 feet, providing for better control and safety. It should be noted that while the laws governing tasers and stun guns are similar, there are some additional requirements on a few states for tasers regarding age, background checks, and permits.
