Rachel Bennett, a spokesperson for CM Counsel, pointed out that medical marijuana has been approved for use in the state of Pennsylvania since April 6, 2016, when Governor Tom Wolf signed the bill into law. This bill, known as Senate Bill 3, allows marijuana use to treat certain medical conditions. She added that despite the fact the law had passed, it was not until February 2018 that the first highly regulated dispensaries opened to provide medical marijuana for those patients who have been granted a license (similar to a prescription) to purchase it. Some of the conditions that medical marijuana is authorized to treat in Pennsylvania directly relate to CM Counsel?s areas of expertise, including anxiety disorder, post-traumatic stress disorder, and sleep disorders.

Bennett stated that the medical marijuana evaluations conducted at their Plymouth Meeting office fall under the responsibilities of their medical staff who handle their Psychiatric Evaluation & Medication

Management services. At CM Counsel they are very aware that a large majority of the population in America

seek out mental health counseling at one time or another and those who never do are often the ones who
