North Texas Food Bank representatives told the Dallas Morning News that they handed out roughly 8,500 meals to local families during a giveaway on Saturday that in years past has seen fewer than 1,000 show up for donations." It goes on to say that apart from affecting individuals themselves, Covid-19 is also changing how charities interact with their beneficiaries. It cites an article published by NBC 5 DFW on November 24th that says a non-profit serving homeless people in Dallas has drastically altered its plans for the year in light of the pandemic. The article from NBC DFW says "For the first time in years, a nonprofit that helps the homeless in Dallas will not serve a meal on Thanksgiving Day. The coronavirus pandemic has altered plans. They come to OurCalling near downtown Dallas because they've been here before or because they don't know where else to go. The pandemic is bringing more clients to the doors of the nonprofit."

The article finally concludes that charities now have a whole new slew of issues to deal with from an increase in people to care for, to abiding by CDC and local health guidelines. These make charitable endeavors more challenging.
