

# U.S. Attorney Erin Nealy Cox Steps Down From Public Office

Dallas federal prosecutor Attorney Erin Nealy Cox has announced that she is stepping down from public office. Cox served as Dallas' top federal prosecutor for three years.

Nealy Cox is a cybersecurity expert and former federal prosecutor in Dallas who was sworn into office in November 2017 after being nominated by President Donald Trump. As U.S. Attorney for the Northern District of Texas, she was responsible for prosecuting federal crimes in an area that covers about 8 million people in 100 counties in northern and western Texas.
