Benton went on to say that the biggest health risk from handling asbestos comes with the fact that when asbestos-containing materials are moved, they can spread many microscopic asbestos particles into the air which can easily be breathed into the lungs. Once in the lungs, the body has the difficult if not nearly impossible task of getting rid of these particles. Known health risks from asbestos exposure include such serious illnesses as lung cancer, Asbestosis (scarring of the lungs), and Mesothelioma, which is harsh cancer that impacts the lining of the lungs and other areas of a person?s abdominal cavity. He says that many people are under the impression that there are very few pockets of asbestos left in buildings and other spaces because of the widespread cleanup efforts that were undertaken over the last several decades but

unfortunately that?s not the case. It was used for so many different purposes it would be nearly impossible to eliminate all asbestos-containing materials from homes and commercial properties. The company owner gave as examples that asbestos saw widespread use in such common materials as cementitious siding and wallboard (called transite), asphalt and vinyl floor tile, textured paints, ceiling tiles and panels, fireproofing substances, blown-in insulation, HVAC duct insulation, and roofing shingles. He added that trained asbestos professionals like those at their asbestos removal St Louis company have no problem finding cases of asbestos-containing materials that still exist in many buildings and homes.

The company owner continued by saying that when they tackle large scale asbestos removal problems, they know how to take such necessary safety steps as first sealing off the entire area. He says this is especially important when large scale remodeling or demolition is being done. They also have access to breathing equipment and other specialty disposal materials that are required when removing asbestos.
