As another cost-saving measure, Senior Care Center encourages their community to locate a facility with a ?buy-in? structure rather than a monthly rent. These allow residents to put a down payment upfront and essentially purchase their apartment or condo in the assisted living facility?s complex. This one-time premium is sometimes offered as an option, with lower monthly costs for residents who take that route.

Once a facility has been chosen, the next step is to look for ways to reduce monthly expenses. This is only possible with institutions that allow personalizing service plans, where one would be looking to cut down on non-necessary service options to help reduce any recurring costs. The organization states that it is important to compare these prices as, in some cases, an inclusive pricing package might be less expensive than the a la carte option.

How much one can lower the cost of these services will also depend greatly on the state and area that the facility is located in. The lower, more affordable states can offer these services starting at \$32,400 per year, while other states have few options below \$72,000. Rural areas will have lower costs, though this does not reflect on the quality of the facility's service compared to more expensive centers in an urban area.

Among other tips to keep assisted living costs down, Senior Care Center advises their readers to plan ahead of time before they need to move into assisted living. Negotiating price flexibility with the facility is also a possibility, as some may offer move-in incentives or are willing to negotiate costs. If possible, they also advise considering the possibility of moving to a less expensive location.

Ryeback says, "While being near family can be very important and can justify you paying more, moving somewhere where assisted living costs are not as steep can prove more beneficial in the long run. Even if you end up having to pay for trips to visit your family, you could still save thousands of dollars a year. These are all details you want to consider ahead of time and possibly discuss with your family.
