While not completely covered by government assistance programs, one can receive financing that will cover a part of the cost of assisted living and long term care. The coverage for these programs varies depending on the state, and certain regions will have different requirements for eligibility and amount of coverage. Programs like Medicaid can subsidize payments for long-term care facilities, specifically nursing homes. However, only certain assisted living facilities or nursing homes will accept Medicaid as payment. Therefore, it is best to check what sort of financial assistance is accepted with each facility being considered.

Medicaid is not the only option for government assistance, as the Department of Veteran Affairs has programs designed to help veterans with coverage, including nursing homes. Depending on the program, spouses of veterans are also included in the coverage. The VA will subsidize certain services? but the program notably does not cover rent and living expenses.

Another option is to seek personal funding and loans, as government coverage is not a guaranteed source for some people. In fact, most end up using their personal funds (such as retirement savings, pension or social security) to cover senior living expenses. On the other hand, long-term care insurance can help cover the costs of assisted living. There are also other ways to finance assisted living costs, such as reverse mortgage loans, home equity loans or bridge loans.
