

Instagram Celebrity Salt Bae Encounters Legal Woes While Preparing to Open Dallas Steakhouse Restaurant

Internet celebrity Nusret Gokce, who is better known as ?Salt Bae,? is encountering legal issues even before he has opened the Dallas branch of his very popular steakhouse brand, Nusr-Et. After more than two years of planning, the Dallas restaurant finally has an opening date. However, on January 21, 2021, Dallas-based construction firm BengeTexas filed a lawsuit in Dallas County District Court claiming that Salt Bae owes them more than \$933,000 in unpaid bills that are due to BengeTexas and its subcontractors for the construction of the restaurant located at Pearl Street in downtown Dallas.

Nusret Gokce, who is a chef, has been providing some details about the Dallas branch of his Turkish steakhouse Nusr-Et through Instagram during the past couple of days. Gokce gained popularity on the Internet for his videos featuring his unique steak preparation methods and the dramatic flourish in his salt-sprinkling method that went viral.

Meanwhile, Salt Bae has filed a countersuit against BengeTexas alleging that the latter had diverted \$182,000 in subcontractor payments to former Nusr-Et employee Steve Regan. Nust-Et claims that this was a scheme to defraud the restaurant. Nusret Gokce also claims that the \$574,000 indicated in the lien affidavit

is wrong.
