Those who have a felony conviction cannot be employed by the federal government, including the US military. They will also be excluded from any government aid, even if they have paid into those programs like: social security and unemployment, Section 8 housing and food stamps, and federal grants and loans.?

The average person's knowledge of the law is more than likely limited to what they see on television or read in newspapers and books. When they do get involved with the criminal law system, they do not know what to do, or how to handle the situation.
