The workers? compensation law in California offers a no-fault system for distributing benefits, which means that as long as the injury had occurred at work, although with some exceptions, assistance can be provided. Once it has been shown that the health condition of an employee is due to a workplace accident or other job factors, the worker is covered. There are four available benefits through the workers compensation laws and the amount that can be collected and availability of these benefits will depend a lot on the nature and the extent of the illness or health condition, including the administration of the policy by the insurance firm.

With regards to the workers? compensation work injury claims process, each local district office of the Workers? Compensation Appeals Board (WCAB) has judges who hear disagreements and will issue decisions that will be binding for all concerned parties. Every victim has the right to have an attorney at any time during the claims process and to file a lawsuit with the WCAB. It is typically a good idea to have a lawyer because the claims process, although a no-fault benefits system, is extremely adversarial.
