The top chiropractic clinic in Riverdale cautions victims against ignoring medical treatment after the accident. Dr. Valentina Adcock, the leading Riverdale, GA, car accident chiropractor, advises the need for timely medical care immediately after the car crash to prevent the risk of any hidden injuries.

On the top of the list of what not to do is leaving the scene of the accident. Dr. Adcock warns victims not to leave the accident site, which may be considered a felony, suggesting, "Once you've stopped in a safe place, check yourself for visible injuries."

According to the top Riverdale car accident doctor, some injuries lay dormant and require a professional diagnosis. Not getting a medical diagnosis is another mistake most victims make and should avoid, advises the Riverdale chiropractor.

Another mistake commonly made in car accidents is not calling the police. Dr. Adcock stresses the need for car accident victims to report the incident to the police immediately and obtain a police report that documents the details of the crash. A police report is an important piece of evidence for a victim to prove their personal injury claim. In a previous press release, the Riverdale car accident chiropractor shares tips for back injury compensation.

Car accident victims should not ignore the importance of information exchange with the at-fault driver. The car accident chiropractor in Riverdale, GA, emphasizes exchanging contact and insurance information with everyone involved in the accident, adding, "If the other parties don't cooperate, this information should be available on the police report."

Dr. Adcock advises car accident victims not to leave the accident site without talking to eyewitnesses. "This will give you someone else with a first-hand account of the accident that can verify your account."

Another common mistake is not notifying the insurance company, says the Riverdale chiropractor, emphasizing the importance of informing the insurance about the accident. "Your insurance company needs the details of the accident to help them determine who was negligent, how your policy rates will be affected, and what claim you can file for vehicle damage," advises Dr. Adcock. One mistake that some car accident victims make is to say sorry or admit guilt before the insurance company. The experienced chiropractor cautions against admitting guilt.

Some victims are unaware of the statute of limitations in Georgia and delay filing a personal injury claim, making it easy for the insurance company to deny their compensation. The need for timely medical care cannot be ignored. Dr. Adcock advises victims to schedule an appointment with a professional Riverdale car accident chiropractor to diagnose any hidden injuries and design a treatment plan tailored to their needs.
