He wrote that even going in a ditch is better than being involved in a head-on collision. The article wrapped up by talking about steps someone can take to avoid having a potentially deadly rollover incident. This includes maintaining a safe following distance, not operating a vehicle under the influence of drugs or alcohol, watching out for debris in the roadway, and avoiding distracted driving situations.
