Also, sometimes, parents need a lawyer because parenting time or other issues indicated in the support order have to be addressed. If one parent will not follow the custody or visitation agreements set forth by the court, additional enforcement efforts from the court may be required.

Like all issues involving family law, the need for modification or enforcement of support orders relies on the divorced couple's unique situation. There are no hard and fast rules for when an effort has to be made on changing support.
