The rate at which motorcycle fatalities occur is 29 times higher than car occupant fatalities per vehicle mile traveled. The next logical precaution is to check the weather every day and to opt out of riding the motorcycle on days when the risks are high. This can include days that forecast rain, ice, or snow that make for slippery roads. If a downpour is expected, riders should consider using their primary vehicle for travel instead of using a motorcycle that might be difficult to control in less than ideal conditions.

Regular upkeep of the motorcycle is also an important step of being a responsible rider. The common parts of the vehicle such as headlights, taillights, turn signals, brakes, fuel, oil, tire pressure, mirrors, handlebars, and horns should be inspected before every ride and should be ascertained to be in proper working order.

While on the road, motorcycle riders should follow all traffic rules, follow the speed limit, use all signals, and respect the right of way of other vehicles. The rider should also maintain a safe distance from all vehicles as one may end up in the blind spot of a much larger vehicle leading to an accident. To increase visibility to other vehicles on the road, wearing bright or reflective clothing is also recommended.
