The key in a wrongful death case is that the accused owed the deceased a certain level of care and, due to negligence, failed to deliver that level of care.?

If a client?s loved one was involved in a car accident and died during or because of the accident, the client may have a wrongful death claim. Traffic fatalities may be considered wrongful death if the other driver caused the accident by driving in a careless or reckless or manner. For instance, the other driver may have been under the influence of drugs or alcohol or was texting while driving.

Medical malpractice may also result in wrongful death. For example, the surgeon may have committed a mistake in surgery. And in the workplace, if an accident results in the death of an employee, it is possible that wrongful death may have occurred. For instance, the company may be responsible for not providing the necessary protective gear or failed to consider the disabilities of the worker when assigning work.

the deceased a reasonable level of care and what was that level of care. Second, it must be shown that the accused, because of their negligent actions or behaviors, failed to provide that reasonable level of care. And third, it must be proven that the failure to provide that reasonable level of care directly resulted in the death or conditions that led to the death of the deceased.

With regards to the compensation, determining how much is owed as a result of the loss of a loved one will be a complex issue. Compensation can cover: the medical bills incurred after the incident and later leading to the death of the loved one; expenses for the funeral, burial, or memorial service for the loved one; lost income of the deceased that was previously used to support somebody; and additional compensation for the emotional distress suffered by the family, which is difficult to quantify.

Typically, the insurance company of the accused will have their own lawyers with the goal of persuading the plaintiff to agree to the lowest possible settlement.
