There are a number of reasons why truck accidents occur on the roads, says the personal injury firm. In 2019, over 360 deaths occurred on Minnesota roadways, according to the Minnesota Department of Public safety. Speed, drunk driving, unbuckled motorists and distractions, all of which can in some way be defined under negligence, were the main causes of this.
