Injured workers often find themselves talking to an insurance claims adjusters who usually: undervalue lost wages; deny legitimate claims; discourage them from asking for a second medical opinion; pressure the injured workers to return to their work too soon; refuse significant claims for permanent injuries, emotional damages, and scarring; and refuse to accept responsibility for conditions that cause multiple injuries.
