CVO resulting in substantial bodily harm is also a felony and the maximum penalty is three years imprisonment and a fine of \$10,000. CVO with bodily harm is a gross misdemeanor offense with a maximum penalty of one year imprisonment and a fine of \$3,000. The firm can help clients in their defense against such accusations.

Robert Ambrose has also developed a reputation as an expungement lawyer. When the new Expungement Law in Minnesota came into effect on January 1, 2015, many people were given a second chance to clear their criminal records. According to the new law, all gross misdemeanors and misdemeanors have the possibility of being expunged and the Attorney Robert Ambrose can help them. Some felony offenses are also eligible for expungement.
