With regards to workplace accidents, Georgia's workers' compensation laws offer coverage for medical bills and lost wages. In some instances, victims of workplace accidents may also be compensated for the pain and suffering that they experienced. While pain and suffering are not covered by the workers' compensation laws, they can be claimed against third parties, such as co-workers, who negligently or intentionally caused such injuries.

Products, if defective, may also cause harm or injury to people. These may be due to: design defects, improper warning or usage levels, or manufacturing defects. Those who believe they have been harmed by a defective product can request for a free case evaluation from the firm.
