According to a news release from the Bureau of Labor Statistics dated 25th March 2021, fatal work injuries reached a total of 207 deaths in Georgia in 2019. When the numbers are analyzed based on industry, the private construction industry had the highest number of fatalities as it accounted for 47 deaths. This amounts to almost one in four work-related deaths in the state of Georgia. The deaths can be further differentiated based on the fatal event or exposure that caused it such as transportation incidents, violence or other injuries by persons or animals, exposure to harmful substances or environments, electrocution, being struck by an object, being caught in or between other objects, and finally falls, slips, and trips.

Construction sites are a particularly dangerous environment when even the tiniest slip-up can mean devastating, often fatal, consequences for those caught on the wrong side of a machine or piece of equipment. Construction sites require strict adherence to policies such as the use of proper personal protective equipment like hard hats, hearing devices, full-body suits, foot protection, eye protection, and others depending on the types of hazards that workers are most likely to encounter at the site. The bounds of the sites are also clearly defined with the use of signs and tape to prevent civilians from straying onto the site. There are also signs everywhere that remind workers of the precautions that they should take to ensure a safe work environment for everyone present on the site.

However, no number of safeguards can ensure that accidents won?t happen. When an unfortunate event does occur, there is generally a thorough investigation into the cause of the incident from all parties involved. The determination of which party was responsible for the accident requires a detailed combing of federal and state safety laws. The investigator has to obtain records that document the work processes on the site. They will then trace back the events that occurred using the evidence present to determine the root cause of the accident.
