Once the initial petition is filed, it must be served to the other spouse. The spouse will have 30 days to respond to the petition. Within the petition, you may choose to include claims to property, custody details, spousal support, and attorney fees. To keep the process as efficient as possible, a divorce attorney can handle the division of property and related negotiations."

If the divorcing couple has children, the divorce procedure will also include a ruling on child support. Meanwhile, the issue of child custody is one of the most complex elements of a divorce and it is essential to enlist the assistance of a divorce lawyer who can help a person navigate the local laws and processes. In San Diego County, this starts with a legal mediation. A judge can decide on child custody and visitation, or the parents can come to an agreement. There may be other considerations in a particular case, such as military orders, health issues, financial considerations, and geographical relocation. After the initial mediation is completed, one or both parties may want to reexamine the case and request for changes to the child custody agreement.

With regards to child support, spousal support, and alimony, the help of a divorce attorney may also be required. In California, there are 47 child support agencies that can create and enforce orders for child support and medical support. Any guardian of the child or either parent can initiate a child support case, whether or not there is already a child support order, and a case is automatically opened when a child gets public assistance.

An alternative to divorce is legal separation, where the two parties continue to be legally married but may decide to live separately. As a result, they will no longer jointly acquire assets or debts. Some couples may opt for separation due to health, religious, or financial reasons. This can affect tax filings and prohibits each party from getting married again. With the help of a divorce attorney, a couple may decide if legal separation is really the appropriate option for their family.

According to San Diego family law, both parties who are separating or divorcing must have equal access to legal representation. One party may choose to pay for the attorney fees of the other party. Both parties may also use communal funds for the payment of legal fees.

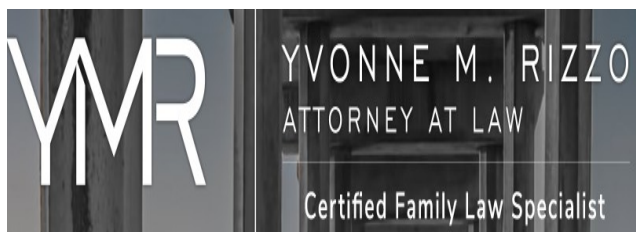
