The Center for Disease Control approximates that around 800,000 people seek medical help for dog bites every year. The real number of dog bites is assumed to be 6 times that number as most go unreported or are handled through simple first aid. In 2014, the insurance industry paid off more than \$530M in claims related to dog bites.

In Georgia, the law surrounding dog bites is a modified version of the one-bite rule. The one-bite rule states that once a dog has bitten a person, it is considered vicious and the owner is assumed to be aware of its nature from that moment on. This makes the owner liable for any future damages that their dog causes to others. Georgia goes beyond the one bite rule and decrees that the owner can be held liable if they were careless and did not keep the dog on a leash or the attack was unprovoked. Georgia law also considers other aggressive behavior from the dog such as charging at people or animals, growling, snarling, or barking to be enough to prove that the owner is aware of the dog's nature and hence can be held liable for its behavior.

These modifications give the victim more options in making a stronger case against the dog owner.

An experienced dog bite attorney will use their knowledge of the law to help victims suffering from the careless actions of a dog owner. The most important step in the process is to establish blame and to hold the owner of the animal liable for the harm caused to the victim. Once the blame is established, an attorney will assess the damage and come up with an exhaustive list of costs that includes current medical bills, expected future medical costs, lost wages due to recuperation time, and in some cases, compensation for any permanent disabilities that may have occurred. Along with the cost of recovering from physical injury, a lawyer may also help the victim push for punitive damages.
