It is important to note that Georgia injury laws allow an injured individual to file a claim in a number of

circumstances. Each type of claim is different and should be handled by a personal injury attorney who is accomplished in that particular law. At Kenneth S. Workplace accident cases need to be handled with care by experts because Georgia's workplace laws are quite complex. Those who have been injured while on work duty have the legal right to make a worker's compensation claim to recover the costs of medical treatment and any kind of permanent disability that may arise because of the injury. Victims will need to file their claim under the proper law or their case might be dismissed. Also, in some situations, it is possible to avoid worker's compensation law and ask for damages directly from the third party that is responsible for the injuries. This is possible when the injuries were caused by the negligence of a party other than the employer. The personal injury lawyer will carefully examine the facts surrounding the incident and will direct the case to the appropriate individuals or business.

Aside from workplace accidents, the personal injury lawyers can also help protect the legal rights of victims of car accidents, bicycle accidents, slip and fall accidents, pedestrian accidents, defective products, nursing home abuse, medical malpractice, premises liability, construction accidents, and dog bites. Motor vehicle accidents are a common cause of injury but they can cause serious injuries and even death, especially if the vehicle involved is an 18-wheeler truck. Bicycle accidents are also quite common and are usually caused by driver error or other conditions, such as dangerous intersections or poorly-maintained streets. Because of the seriousness of injuries caused by bicycle accidents, victims need to consult with a personal injury attorney to protect their legal rights.

Property owners and employers may be held responsible for the injuries if it is proven that they neglected to remedy the dangerous condition despite knowing about it.
