According to the Georgia Department of Public Health, there are around 800 to 900 accidents involving bicycles in Georgia every year with approximately 80% of them resulting in injury. Being in a bicycle accident is a particularly injurious affair compared to other modes of transport because a bicycle doesn't afford the same kind of protection that an enclosed vehicle does. Bicycle riders are also more susceptible to accidents as a sizeable chunk of vehicle drivers tend to not respect bicyclist's personal space and their equal rights to use the road.

If a bicyclist has been in an auto accident, the law firm of Kenneth S. Nugent P.C. says that they should display the presence of mind to collect the information that is going to bolster their case against the driver who is at fault. The first step is to collect the information about the driver. The driver's contact information is key to presenting the evidence to the judge and getting a settlement from the driver's insurance company. Once the driver is identified, the bicyclist should try to gather the contact information of those who were present at the scene of the accident. If the case goes to trial, witness testimony is going to hold a lot of weight in establishing fault. The bicyclist should also try to notice the presence of security cameras nearby that can provide footage and act as conclusive evidence during the settlement or a trial.

Finally, once the bicyclist is done with collecting all the information at the scene of the accident, they should immediately get a medical checkup that evaluates their injuries. A doctor's evaluation will help the victim build up a strong case against the driver who was at fault. It will help in determining the extent of injuries so that the settlement can account for the medical expenses that the cyclist is currently facing and those that they are likely to face in the future. Not all physical injuries are instantaneous. Some take a long time to

manifest themselves. Recording the physical injury at the time of the accident gives the victim's legal counsel the ability to ask for compensation for future medical expenses. The victim should also keep track of the money they have lost from being unable to work due to the time needed for recuperation.

A spokesperson for the law firm talks about the avenues available for a bicycle victim to appeal their case by saying, ?Bicyclists are most likely to bear the brunt of errant drivers who don't show any inclination of sharing the road with them.
