It often goes unsaid that cases involving domestic violence often invoke emotions and highly stressful situations. Attorney Robert H. There are several levels and types of domestic assault. The first of these is Misdemeanor Domestic Assault, which has a maximum sentence of up to 90 days in jail and a \$1,000 fine. A person may face this possible punishment if they intentionally cause fear of immediate bodily harm or death, or intentionally inflict or attempt to inflict bodily harm on a spouse or family member. For any clients who have faced such a situation, the Ambrose Law - MN Defense Attorney has the experience and knowledge to support the client and their family throughout the case.

Another type of domestic assault, Gross Misdemeanor Domestic Assault, carries a maximum penalty of up to a year in jail and a \$3,000 fine. A person may be charged with this if they commit one of the acts of Misdemeanor Assault within a decade of a domestic violence-related offense conviction or adjudication of delinquency. Felony Domestic Assault carries a maximum penalty of up to five years in prison and a \$10,000 fine.

One of the higher levels of this crime is Domestic Assault by Strangulation, which is classified as a Felony Offense, carrying a maximum penalty of up to three years in prison and a \$5,000 fine. A person may be charged with this crime if they assault a family or household member by strangulation. For legal purposes,

strangulation is defined as intentionally impeding normal breathing or circulation of blood by applying pressure on the throat or neck, or by blocking the nose or mouth. Several degrees of assault may also be considered in certain circumstances, with the Ambrose Law Firm - Minneapolis Lawyer specializing in handling such criminal cases. Their expertise in domestic assault cases is clear in their recent win, as they successfully argued their case in a jury trial.
