While an injured individual is rehabilitating, they might suffer financial setbacks such as lost wages due to the time for recuperation, cost of medical bills, and personal property losses. The victim might also suffer indirectly due to the accompanying mental anguish and a tarnished image. Some injuries, such as whiplash, might not manifest themselves immediately and could show up weeks or months after the incident.
