The California wrongful death law provides surviving family members or the estate of the deceased to file a lawsuit for damages when the death was the result of another person's wrongful act, whether it was intentional, reckless, or negligent. This is specified in the Code of Civil Procedure 377.60. The damages may include but are not limited to: funeral and burial costs; compensation for the loss of the support and companionship of the deceased; and the amounts that would have been earned by the deceased as income.

It is important to note that punitive damages are not available in a California wrongful death lawsuit. Punitive damages may only be obtained through a California "survival" cause of action under CCP 377.30. Survival causes of actions are filed on behalf of the deceased person's estate as compensation for losses suffered by the victim from the wrongful act.
