A wrongful death lawsuit can be filed by the surviving family members or by a representative of the estate of the deceased, on behalf of the surviving family members who have been impacted by the passing away of that individual.

The wrongful death law in California allows surviving family members or the estate of the deceased to sue for damages when the death was caused by another person's wrongful act, whether it was reckless, negligent, or intentional. This has been specified in the Code of Civil Procedure 377.60. The damages can include but are not limited to: compensation for the loss of the support and companionship of the deceased; the amounts that would have been earned by the deceased as income; and funeral and burial costs. And it is important to remember that the statute of limitations for wrongful death is two years.

It is also important to note that punitive damages will not be available through a California wrongful death lawsuit. Punitive damages may only be obtained through a California "survival" cause of action under CCP 377.30. Survival causes of actions will need to be filed on behalf of the deceased person's estate as compensation for the losses that have been suffered by the victim, and not the losses suffered by the surviving family members, from the wrongful act.

The Glendora accident injury lawyer also wants to advise the parents of kids who have been involved in an accident to visit a physician or chiropractor after the incident even if there are no apparent symptoms in their children. They also advise parents to set aside some of their time no matter how busy they are to ensure that their children who got involved in an accident will get the proper medical care or else their condition might not be diagnosed properly and on time. The impact of the damage, physical or emotional, may have lingering effects that affect them for a very long time. Some of the indications to look for are: nightmares or unjustified fear; headaches; and back or neck pain.

The parents will need to find a personal injury lawyer who really understands kids because there are certain unique issues that can have a significant effect on kids. Injuries in children may ultimately result into serious mental issues that they may suffer from for the rest of their lives.
