Under this law, all misdemeanors and gross misdemeanors have the potential to be expunged. There are also certain felony offenses that are eligible for expungement.

Even in those cases where someone was not convicted of the crime charged, there are still records that remain with the Bureau of Criminal Apprehension (BCA). The firm has even observed cases where an


