The CVO charges will depend on the nature of injuries incurred by the victim, which include bodily harm substantial bodily harm, great bodily harm, and death. If the accident resulted in the death of a victim, CVD may be charged if the death does not constitute murder or manslaughter and the driver was negligent and/or under the influence of alcohol or a controlled drug.

Meanwhile, the law firm also handles all levels of drug crimes, from felony first degree sales of a controlled substance to misdemeanor possession of marijuana in a motor vehicle. The Fourth Amendment protection against unreasonable searches and seizures may be key in the defense for such cases.

Felony cases include: assault, drug crimes / drug possession, weapons charges / felon in possession, robbery, burglary, fraud / theft / financial crimes, white collar crime, Internet crimes, criminal sexual conduct, felony DWI /DUI, and CVO and CVD.

Gross misdemeanor cases include: DWI / DUI, CVO, driving in violation of a restricted driver?s license - no use of alcohol (B-card violation), assault, violation of a domestic abuse no contact order (DANCO violation), theft, and criminal damage to property. Misdemeanor cases include: DWI / DUI, theft, domestic assault, driving after revocation, trespass, criminal damage to property, and disorderly conduct.

Juvenile law cases include: assault, drug crimes / possession / sale, driving offenses (DWI / DUI, underage drink and drive), and alcohol crimes (possession, underage consumption). Those who are interested in getting the services of a criminal defense lawyer can request for a free consultation.


