If so, you need to gather as many details together before making a phone call to the attorney's office. Take a few minutes and search your immediate vicinity for paperwork to obtain important facts that you can relay to the law firm. It may be a good idea to make a phone call to a friend or family member to collect crucial information."

Pedestrians who have been hit by a motor vehicle will need to obtain good and detailed evidence and information. For instance, it would be necessary to get the driver's name and address, as well as insurance coverage information. If the injuries are too serious and prevent the victim from getting the relevant info, they may ask for help from a police office or medical response team or any other person who may be able to get the required information. The accident victim may then contact the driver's insurance company, report the incident, and file a claim. The victim should also contact his or her insurance company to report the accident.

The next step is to show that the driver was definitely negligent and that this was the cause of the accident. Failure to get evidence that the driver was negligent will result into the failure of the claim. Thus, right after the accident, the pedestrian hit by a car must start asking questions to determine if the driver was really at fault and also find out if there are witnesses who can say that the accident was clearly the driver's fault. After gathering all information relevant to the case, it is time for the accident victim to consult with an Orange County accident lawyer.

It is also important to file the lawsuit as early as possible because the statute of limitations for pedestrian accidents is only two years from the date the injury occurred, including the day when the collision occurred. If the proper documents were filed at the appropriate court beyond the statute of limitations, the case will be dismissed. There might be an extension, which is called "tolling," when certain circumstances are present. However, complex legal principles must be applied to find out if the exception is applicable. That is why it is essential to consult with a dependable personal injury lawyer.
