Each year, the US Medicare program may lose significant funds because of the fraudulent activity committed by private citizens and organizations that work with the Medicare program. This impacts each and every taxpayer and is a significant drain on the Medicare program. Considering the government's shortage of resources to police and hold defrauders accountable, it must often depend on individual health care workers in the market to come forward with info so they can hold those who defraud the program accountable.

"Fraud against the Medicare program can take many forms," stated the New York Medicare whistleblower lawyer "It can be manipulating healthcare records in order to get paid more from Medicare, surcharging the government, providing subpar healthcare services or products, or many other things. The government counts on private whistleblowers to come forward with firsthand knowledge and proof of this conduct and the government compensates them for their crucial support. Through qui tam lawsuits, whistleblowers have the ability to bring civil claims against those parties on behalf of the government under the False Claims Act and can be rewarded for it."

The federal False Claims Act is a federal statute that renders it criminal for any entity to make incorrect Medicare claims or otherwise defraud the government. It likewise makes it possible for healthcare personnel with knowledge of scams against the Medicare program to submit a whistleblower legal action on behalf of the federal government. In exchange for their details and effort, the whistleblowers are entitled to collect incentives of between 15 and 30 percent of the funds recovered by the government. The act additionally has regulations for whistleblower protection against any company retribution that may result from filing a lawsuit or consenting to work with the federal government.

When a whistleblower steps forward with relevant information concerning Medicare scams, the case is filed in federal district court. It is put 'under seal' while the Department of Justice examines the lawsuit and the evidence, interviews witnesses, and speaks with specialists and agency workers. The government will then choose if it will participate in the lawsuit. If it does not choose to step in, the whistleblower still may continue the case on their own.

Since healthcare workers may place themselves personally at peril doing this crucial work, the federal False Claims Act particularly incentivizes them with a considerable portion of the financial recuperation. In a successful claim, the government can recover up to 3 times its losses as well as penalties for each incident of fraud.
