5. INVOLUNTARY DEVIATE SEXUAL INTERCOURSE

6. RAPE
7. SEXUAL ABUSE OF CHILDREN
8. SEXUAL EXPLOITATION OF CHILDREN
9. SEXUAL ASSAULT
10. STATUTORY SEXUAL ASSAULT
