Every year, the national Medicare program may lose significant funds as a result of fraudulent activity performed by individuals and entities that deal with this program. This type of activity impacts each and every taxpayer and is a substantial drain on the Medicare program. Arvind Bob Khurana, a prominent healthcare whistleblower lawyer, helps healthcare workers in Mississippi who may have evidence of Medicare scams bring civil lawsuits against these parties on behalf of the government. The CMS (Center for Medicare and Medicaid Services) contracts with numerous people, businesses, and entities that manage Medicare repayments and file claims. The CMS must essentially rely upon that these people and companies remain in compliance with the rules. Regrettably, numerous are not in compliance, and that number is getting bigger. Due to the government's shortage of resources to police and hold cheaters liable, the government has to often count on individual health care employees in the industry to come forward with information so they can hold those who defraud the program liable.

"Fraud against the Medicare program can take many forms," said the Mississippi healthcare whistleblower lawyer "It can be manipulating healthcare records so as to get paid more from Medicare, overcharging the government, providing low-quality services or products, and many other activities. The government depends on private whistleblowers to come forward with firsthand knowledge and evidence of these behaviors and the government rewards them for their critical assistance. Through qui tam suits, whistleblowers have the ability to bring civil claims against those parties on behalf of the federal government under the False Claims Act and can be rewarded for it."

The federal False Claims Act is a federal law that renders it criminal for any business entity or person to make incorrect Medicare claims or otherwise defraud the government. It also enables healthcare personnel with information of scams against the Medicare program to file a whistleblower claim on behalf of the government. In exchange for their details and effort, the whistleblowers are entitled to gather financial rewards of as much as 15 and 30 percent of the recovery by the federal government. The act additionally has regulations for whistleblower shield against any company retribution that results from submitting a lawsuit or agreeing to a deal with the government.

When a whistleblower steps forward with relevant information regarding Medicare scams, the case is filed in federal district court. It is put 'under seal' while the Department of Justice examines the complaint and the proof, speaks with witnesses and seeks advice from professionals and agency workers. The federal government will then choose if it will step in. If it does not choose to participate, the whistleblower still may continue the case on their own.

Due to the fact that healthcare workers may place themselves at peril doing this important work, the federal False Claims Act particularly incentivizes them with a significant part of the financial recovery. In an effective claim, the government can recuperate up to three times its losses to fraudulent activity in addition to penalties for each occurrence of fraud.
