Oftentimes, compensation can be obtained from the homeowner or car insurance policy of the negligent person. There are three kinds of legal damages available in California. These are economic damages, non-economic damages, and punitive damages. Economic damages are due to the lost financial contributions that the decedent had been providing to the family. Non-economic damages are for the lost companionship, pain and suffering, loss of protection, loss of medical coverage / pension, and more. Punitive damages are for punishing the defendant for bad behavior.

Meanwhile, if the decedent is a child, by getting the help of a child injury lawyer Glendora parents, grandparents, and other loved ones who have suffered damages because of the death of the victim can file a claim. And whether the victim is a child or an adult, this claim for wrongful death can be filed against a broad range of people, businesses, and even government agencies. For instance, if the person died due to a fatal slip and fall in a commercial establishment, the company who owns that establishment may be held liable for failure to ensure the safety of that store. If a person dies because of an accident caused by a drunk driver, the claim will be filed against the drunk driver.
